



## Privacy Statement

**The Murphy Chamber of Commerce** is committed to protecting your online privacy. You may visit most pages on this site without giving us any information. However, sometimes we may need information to provide products or services that you request, and this privacy statement explains data collection and use in those situations. This privacy statement only applies to [MurphyChamber.org](http://MurphyChamber.org); it does not apply to other web sites, products or services.

### Personal Information Collection

You will be asked when we need information that personally identifies you (personal information) or allows us to contact you. Generally, this information is requested when you are contacting us using e-mail or e-mail forms on this site, or requesting/registering for services such as newsletters. Personal information collected by this site often is limited to name and e-mail address, but may include other information when needed to provide a service you requested.

This site also collects information about your computer hardware or software such as IP address, browser type, operating system, domain name, access times and referring Web site addresses.

We collect information about which [MurphyChamber.org](http://MurphyChamber.org) pages you visit. This site visitation data is identified only by a unique ID number, and it is never linked with personal information unless a user consents as described below.

### Personal Information Use

We will only use your personal information for the following purposes:

- To ensure our site is relevant to user needs
- To deliver services, such as delivery of news and newsletters that you request
- To help us create and publish content most relevant to you
- To alert you to updated information where relevant
- To allow you access to limited-entry areas of our site as appropriate.

- As a business service to our membership, on request, we will provide to Active Members of the Murphy Chamber of Commerce the e-mail and/or mailing address of its members for the purpose of offering promotional or informational content.

Murphychamber.org may disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform with the law or comply with legal process served on Murphychamber.org; (b) protect and defend the rights or property of Murphychamber.org and its web site, or (c) act in urgent circumstances to protect the personal safety of Murphychamber.org employees, users of Murphychamber.org services, or members of the public.

## **Personal Information Control**

When you give us personal information, Murphychamber.org will not share that information with third parties without your permission, other than for the limited exceptions already listed. It will only be used for the purposes stated above.

We may send out periodic e-mails informing you of services, or updates to newsletters or other services you requested, or confirming you requested a product or service. You will of course be able to choose to unsubscribe to these mailings.

Except as stated above, we will not pass your personal details to anyone else, except for successors in title to our business, and suppliers that process data on our behalf.
